#### 18.4 Fallen Trees

A resident has reported fallen trees blocking NCN Regional Cycling Route 71, and the Baker Way walking route, at Hockenhull Platts, Tarvin. The tree is very close to the Grade II listed packhorse bridges over the Gowy built in the 17th Century. Previously unknown archaeology has been exposed by the tree bole which may be associated with a mill which once existed in the vicinity at an earlier date.
