16/123 DECLARATIONS OF INTEREST, DISCLOSABLE PECUNIARY INTERESTS, AND DISPENSATIONS

16/123.1 New Written Requests for Dispensations

16/126 REPORT ON OPEN FORUM (This was not reported to Council in the formal meeting. It is a record of the items raised in the Open Forum)

The draft response that Councillors had prepared to the Gypsy and Traveller Site Consultation had been read out by Councillor Hardacre. Numerous questions and concerns had then been raised by members of the public. The particular interest in the consultation was due to two of the possible sites being within Tarvin Parish. Questions had been answered as far as possible by Councillor Lush with support from Borough Councillors Devnem and Leather.

16/128 CHESHIRE WEST AND CHESTER LOCAL PLAN (Part Two)

The meeting discussed comments made in the Open Forum along with further thoughts from Councillors.

RESOLVED: (16/128.1) that Borough Councillor Deynem look into the background of WYG to try to ascertain whether they were an independent body as far as the consultation was concerned. This was to respond to a question raised by a member of the public.

RESOLVED: **(16/128.2)** that the following be added to the draft document prepared by Councillors:

- a. intensify comment on the impact on surrounding houses by indicating more precisely the number of properties affected
- b. strengthen arguments concerning the proximity of the site to St Andrews Church and the conservation area.
- c. extend dangers of the surface water drainage channel to include the danger to children d. add dangers of waste dumping to the whole ecological system.
- e. note that the proposed site was on the opposite boundary to two dairy cattle grazing meadows. Any loose or stray dogs from the site on these meadows could cause severe damage to the cattle.
- f. amend the statement about the schools to reflect the fact that Tarvin Primary School was not currently at capacity in all years
- g. add a comment about the local resident who had a life-time tenancy on the land in question stating that he had no intention of giving up the tenancy, nor had he been informed of the inclusion of the land within the consultation.
- h. a suggestion from a local resident that the land may be contaminated due to the burial of carcasses following foot and mouth disease in the 1960s.
- i. a statement about the large attendance at the two Council meetings and the strength of feeling expressed.

RESOLVED: (16/128.3) that the Clerk add the additional comments to the draft and then forward to Councillors via e-mail.

RESOLVED: (16/128.4) that as soon as Councillors were satisfied that the document covered the points as approved by Council the Clerk then

(16/128.4.1) forward the agreed points to Cheshire West and Chester Council

(16/128.4.2) place copies of the document on the Council Website and Parish Noticeboards.
