f. **Fallen Tree** - A Mountain Ash tree at the bottom end of the field was badly damaged during poor weather on 27th April 2019 – all that remains is a 2m high stump. Under the circumstances the Clerk has asked Canopy Tree Care to carry out a full inspection of the trees on the field.

22. STREET NAMES AND SIGNAGE

a. Should the area known as Weetwood, between Oscroft and Willington be recognised on the Tarvin Parish sign on Willington Road, east of Common Lane and on leaving Oscroft hamlet? It is a recognised geographical area but is currently unsigned?

b. In the same area the unmade road opposite Weetwood Grange, the site of the ex-Weetwood brewery, has 8 properties on in but the lane has no name. This compares with Mill Lane a little further east which is named but only has 7 properties off it. Should Council should survey the residents to ask them if they would like their lane named and if so what? If this was to be pursued CWaC would have to agree.

c. A resident of Kelsall Road, Tarvin Sands said that both CWaC, except for elections, and the Fire and Rescue Service do not recognise their address. This does have consequences because when the Fire Service were recently called out to a fire in a garden they could not locate the address on their system. The PC should be asking CWaC and the Fire and Rescue Service to ensure that their data bases are consistent and up to date.
