RESOLVED: that Councillors Ford, Parker. Ryan, and Twigg meet with MWH treatment Ltd

22/017.2 Meeting with Tarvin Athletic FC

The Clerk had met with a representative of Tarvin Athletic. They were looking to set up a permanent base in Tarvin Parish (building and football pitch) and if they found appropriate land would like the Parish Council to work with them to make it possible.

RESOLVED: in principle to work with the club.

22/017.3 Trees/Grass Park Close

A resident of Park Close had asked the Clerk to draw Councils attention to the following regarding the hedge and grassed area just inside Park Close:

o dying tree that Cheshire West and Chester Council had previously promised to remove

tree that had been blown over

• hedge cutting had been missed by Cheshire West and Chester Council

• the grass had not been cut as the contractors had refused to do it because of the two fallen trees and daffodils

The meeting noted that the Clerk had reported the dying tree to Cheshire West and Chester Council in February 2022 and the other items had been reported since the e-mail had been received.

22/017.4 Gate linking Saxon Heath to Broomheath Lane.

Concerns had been raised by Tarvin Community Woodland Trust regarding the difficulty people have opening the gate.

RESOLVED: that the Clerk write to the Management Company that maintained the area asking them to make access easier and suggest bollards as an alternative to the gate. **22/017.5 Grass Cutting**

There appeared to be different standards and frequencies of grass cutting in and around Tarvin and the following queries were raised:

o along Tarporley Road from the village centre to Brown Heath Farm grass appeared to be cut regularly but from Brown Heath Farm to the A51 junction that wasn't happening

• the A51 from the junction with Tarporley Road to Okell's Nursery was a well-used route by walkers. Last year this route only appeared to be cut once and complaints had been received. The route had deteriorated again due to a lack of grass cutting.

• the grass along Holme Street on the A54 where the trial for the wildflower strategy was taking place had been cut.

RESOLVED: that the Clerk ask Borough Councillor Leather to obtain answers to the above and also seek clarification on the general different standards and frequencies of grass cutting in and around Tarvin.

The report completed by the Internal Auditor was considered.

RESOLVED: that Council respond as follows:

Council understand and fully support the following paragraph taken from the Good Councillors Guide to Finance:

"A council should typically hold between 3 and 12 months expenditure as a general reserve. If the general reserve is too low, then it may not be enough to cover unexpected expenditure or emergencies, whilst if the general reserve is too high then local electors have paid a tax which is not being used for the benefit of the local community."

It was considered that whilst Council's general reserves were only 16% that was more than sufficient on this occasion. When the budget had been set Council had Community Infrastructure Levy money and New Homes Bonus money amounting to more than £30,000 the majority of which had not been allocated to any project. In addition, there were significant earmarked reserves which could easily be used to cover any unexpected emergency.

Council considered that under the circumstances holding higher general reserves on this occasion would have meant that local electors had paid a tax which was not being used for the benefit of the community.
