19/184.1 Planning Applications

19/04216/FUL - Change of Use from retail (A1) to two dwellings (C3) with alterations – 36 High Street, Tarvin

Comment: Policy ED1 of the made Neighbour Plan states that:

Change of use from residential to business will be supported for developments within the Plan area where they provide additional work opportunities and do not compromise the rural setting and do not harm the amenity of neighbours.

Change of use from retail to other business uses within the Settlement Boundary will be supported if the proposal does not result in a net reduction of employment opportunities. Changes of use from retail or business use to residential which require planning permission will not supported unless:

- it can be demonstrated that the continued use of premises for employment use is no longer commercially viable or environmentally acceptable;
- the premises in which the business takes place have been actively marketed for the two-year period immediately preceding any planning application to seek alternative owners or tenants; and,
- the change can be supported by other relevant policies.

N.B. Two years is specified as in current market conditions anything less would, in our opinion, be unrealistic.

We will only support an application when the above conditions are met.

19/04247/FUL - Single storey side and rear extension – 16 Hockenhull Avenue, Tarvin

Comment: No Objections

19/03575/FUL – Change of use of land for the creation of new residential access and drive – Well House, Weetwood

Comment: We object to the proposal and question the need for an additional entrance to the property. We have concerns over potential Highway safety issues and also that the proposal would affect the viability of the existing trees.
