21/059.2 Footpaths in the Parish

Councillors Twigg and Ford gave a PowerPoint presentation highlighting the state of footpaths.

RESOLVED (21/059.2.1): that the following proposals be approved:

• Designate "Pavements" as a Special Project and over the course of the next year we will:

- Identify the extent of the problem
- A section of path be allocated to individual Councillors to monitor
- Councillors to be responsible for monitoring and reporting to CWaC issues that arise on their allocated route feeding back to clerk, who will record and chase to make sure it is actioned
- Meet with and discuss our suggested solutions with CWaC
- Implement a plan to improve the state of our pavements

RESOLVED (21/059.2.2): that the following additional proposal regarding Safer Cycling Routes be approved:

CWaC launched an initiative Walk, Ride and Thrive. Designate "Safe Cycling Routes" as a Special Project and over the course of the next year we will:

- Lobby for the pavement from the A54 road junctions between Shay Lane and High Street (near the King George Playing Field entrance) made into a Shared User Path (SUP) for pedestrians and cyclists - just like the pavement on the other side of By-Pass Road. This would help connect Oscroft and the village centre.
- The exit from Ridgeway onto the footpath could also be cycle friendly.
- The wide pavement on Tarporley Road in front of the Taylor Wimpey homes was built as a SUP but never signed as such and this SUP could be extended up to the top of Tarporley Road to its junction with the bypass. This would make a much safer crossing point for cyclists who could then use the central reservation to cross more safely to get to Cross Lanes on the way to Stapleford.
- · Discuss our suggested solutions with CWaC and explore funding sources
- This can be achieved at relatively low cost by installing the blue and white signage for SUPs on our existing pavements and ensuring that the pavements are kept clear of encroaching vegetation.

RESOLVED (21/059.2.3): that each Councillor cover the area of footpath that they use to deliver newsletters.
