Councillor Ford reported that the above application for prior notification of a change of use under Schedule 2, Part 3, Class Q of the Town and Country Planning (General Permitted Development) (England) Order 2015 had been refused.

Council had not previously been invited to comment on this PDQ application.

# 18/061 KING GEORGE V PLAYING FIELD 18/061.1 Drainage

The work was due to start on 26th June and was expected to take three days. The car park would be closed to the public from the evening of 25th June and remain closed until the work was completed. The main users of the field had been informed and the work and the closure had been publicised on Tarvinonline.

## 18/061.2 Condition of the Field

The order had been placed and the vertidraining work had been scheduled for 11th July and the spraying work for 18th July.

**18/061.3 Scout and Guide Movement – Draft Legal Agreement – housing of CCTV** The Clerk had received the first draft, answered a number of questions, updated the document, and then returned it to Cullimore Dutton. The Clerk had requested an updated draft for Councillors to view.

## **18/062 SECTION 106 FUNDING**

Councillor Twigg had obtained a quotation of £18,987.80 plus VAT for a Trim Trail on the King George V Playing Field. The quote was inclusive of equipment, supply, and installation. The equipment would be positioned along the field on the grassed area between the path running in front of the Tennis Club and the football pitch.

**RESOLVED:** (18/062.1) that the proposal of a Trim Trail be approved, and the quotation be accepted.

**RESOLVED:** (18/062.2) that the Scout and Guide Movement be invited to apply for the balance of the funds, through the Clerk, during the coming month.

**RESOLVED:** (18/062.3) that if the Scout and Guide Movement did not take up the offer, or if their proposal was not acceptable to Cheshire West and Chester Council and Taylor Wimpey, then the balance of funds be used to purchase additional equipment for the Trim Trail.

## 18/063 NOS. 61 AND 61A HIGH STREET

A complaint had been received from a resident regarding 61 and 61A High Street seemingly being used exclusively as Airbnb accommodation with some clients parking offroad on private land.

Council was not aware whether the apparent use of the buildings required any change of use or other approval. The meeting noted that off-road parking on private land was not an issue for either the Borough or Parish Council to get involved in.

**RESOLVED**: that the Clerk ask the Cheshire West and Chester Council Planning Enforcement Team to check that everything was in order.

## 18/064 NOS. 42 - 44 HIGH STREET

Concerns had been raised regarding the new blue "Reades" sign. It was thought that the signage might not have approval as Council had not received an application for comment from Cheshire West and Chester Council.

**RESOLVED**: that the Clerk ask the Cheshire West and Chester Council Planning Enforcement Team to check that everything was in order.

## 18/065 HS2 AND THE IMPACT ON THE A51

Councillor Lush reported that he had attended the Annual General Meeting of the Cheshire branch of CPRE. There had been a presentation on HS2 given by the Leader of Cheshire East Council and her main theme had been the impact on Crewe. HS2 would potentially have a significant impact on Crewe, not just in terms of high speed access to London and Manchester, but also employment growth in Crewe. In response to a question from Councillor Lush it appeared that the A500 to Crewe from the M6 would become a dual carriageway but to date there had been no discussion with Cheshire West and Chester Council on the A51 from Nantwich to the A55. It was considered that as that route was already very congested, particularly at peak times and especially from the Tarvin roundabout to the A55, if Crewe was to become a significant sub-regional employment centre because of HS2 congestion the problem was likely to become even worse.

**RESOLVED:** (18/065.1) that Councillor Deynem ask Cheshire West and Chester Council, as a matter of urgency, to engage with Cheshire East on their plans for Crewe as a consequence of HS2 and how those plans might impact on traffic growth on the A51 between Nantwich and the A55. The ideal outcome being that the two Councils produce a joint proposal for upgrading the road which would be presented to Government for implementation by 2026, the date when HS2 was due to arrive in Crewe.

**RESOLVED:** (18/065.2) that the Clerk also write to Cheshire West and Chester Council requesting this action
