22/122 DECLARATIONS OF INTEREST, DISCLOSABLE PECUNIARY INTERESTS, AND DISPENSATIONS

22/122.1 New Written Requests for Dispensations

There were no new requests.

Members were invited to declare any Disclosable Pecuniary or other Interest in any item of business on the agenda and, if necessary, leave the meeting prior to discussion of that item. 22/129.1 Planning Applications RESOLVED: that the following comments be made

22/03115/FUL - Installation of flue for a log burning stove (retrospective) - Harpers Barn, Ryecroft Lane, Bruen Stapleford

Comment: No Objection

22/03238/FUL - Erection of 2no. Dwellings and a Single Storey Detached Garage - Land At Former Fraser Chadwick Site, By Pass Road, Tarvin

Comment: Councillors have concerns about the scale and massing of the proposed development and although appearing to satisfy space standards and minimum separation distances, the gardens of the properties adjacent to the site are not deep and the new dwelling closest to the boundary could appear overbearing and adversely impact on the enjoyment of their garden with an outlook onto a blank gable – especially as the neighbouring properties are at a lower level to the site.

Issues of surface water drainage run off, contamination from the former PFS, and the ability for vehicles (residents/visitors and deliveries) to manoeuvre within the site in order to leave in a forward direction safely onto the main road – were all matters discussed and the officer's attention is drawn to consider them when determining the application.

Given the length of time it had taken Cheshire West and Chester Council to deal with this application, and in view of the comments received via e-mail from the Planning Officer and the Chartered Town Planner advising Council it was **RESOLVED** that Council write to the Planning Officer confirming that "as no circumstances have changed Tarvin Parish Council wishes the Planning Officer to note that Council is implacably against this illegal development being granted permission for the many reasons previously specified and it hopes that the application will be determined without further delay."

22/130 KING GEORGE V PLAYING FIELD

22/130.1 Scout and Guide Hut – entrance to the building.

Councillor Ryan reported that the work had been completed.

22/130.2 Drains

Councillor Ryan reported that the work given to the contractor had been completed. **RESOLVED**: that the contractor be instructed to replace the broken manhole cover at the rear of the Scout Hut. A quote of £165 plus VAT had been received in July 2022.

22/130.3 Field Management Committee

The minutes of the meeting held on 20th October 2022 were noted.

RESOLVED: that the Clerk ask the contractors who cut the field to fill in the holes in the goalmouth on the football pitch, straighten the goals which were leaning, and try to correct the goal which appeared to be out of shape.

22/131 REQUEST FROM TARVIN AFC

Tarvin Athletic FC were looking to secure land within Tarvin Parish which would be their base and include a football pitch. They had indicated that they would like to set up a working party consisting of people from Tarvin AFC, Tarvin Parish Council, local schools, and other interested parties to develop the project and wished to get it going as a matter of urgency.

RESOLVED: that Council support the proposal and agree to send a representative to attend working party meetings on the understanding that the representative would not participate in any discussion regarding specific land. The reason being that the land would probably require Planning Approval and as a statutory consultee the Parish Council would need to distance itself in order to best serve the residents of the Parish.

22/132 SPECIAL PROJECT – FOOTWAYS

A response was awaited from Cheshire West and Chester Council.

22/133 NEIGHBOURHOOD PRIDE SCHEME APPLICATION
